Credit Terms & Conditions

The charge card, if issued to applicant, shall remain property of Ports Petroleum Co., Inc. (hereinafter called Ports) and shall be returned to Ports upon demand.
This card is a charge card and not a credit card. Applicant shall pay to Ports the full amount due as shown upon receiving the statement.
Any account which is not paid in full by the subsequent statement date shall be deemed delinquent. Delinquent accounts may be assessed a finance charge of up to one and one half percent per month or eighteen (18) percent annually, on the outstanding balance that is 30 or more days delinquent.
Either Ports or applicant may cancel this card by either demanding return of the card or the surrender of the card.
Ports may, at its option, elect to change the terms and conditions hereto. If such election is made, Ports shall notify, in writing, all card users of such election and the content thereof. After thirty (30) days of such notice, such change shall be binding upon all charge card holders.
In the event a card is lost or stolen the applicant shall be liable for all charges until Ports is notified.
The applicant agrees to pay all costs and expenses of collecting delinquent accounts, including (but not limited to) reasonable attorney's fees, incurred by Ports Petroleum Company, Inc.
